#### President's Report:

- President and General Manager met twice for leadership meetings to discuss the rebranding initiative and *Building a Healthy Corridor* Workshop September 14.
- · Held a conference call with Wegner's CPA regarding starting the audit calendar or conduct an audit this year. Board to decide in the next meeting.
- President thanked Board member Colleen Pancake for her 6 ½ years of service to the Board of Directors.

#### **GM** Report:

- National Cooperative Grocer (NCG) Fall Meeting will take place Sept 12-15 in Minneapolis, and General Manager attendance is mandatory.
- Unclaimed Property Tax time is approaching. ONF has approximately \$43,000 of unclaimed funds to release to the state.
- 38 employees received raises. GM states it is time for ONF to start investing in the future and go in a bold new direction. Cooperative Development Services (CDS) consultant recently reviewed store operations. Offered insight to labor hours, merchandising, category management, operational efficiencies, marketing and branding.
- · Kevin O'Donnell from CDS Consulting recently spent several days reviewing A la Carte operations including; goals, training, and labor hours. Further customer service training to be provided at ONF.
- GM is on the College Avenue Redevelopment Committee. Committee working toward redeveloping the central corridor to make it more walking, biking and urban friendly.
- Discussed the Amazon Locker and how technology is affecting retail; also discussed Whole Foods purchase.
